## **Appointment of Americas President**

Nikko Asset Management Co., Ltd. (Nikko AM) announces the appointment of Mark E. Stoeckle as President and Country Head of Nikko Asset Management Americas Inc. The appointment takes effect 1 September 2025, the same day the entity will be renamed Amova Asset Management Americas Inc.

Since April 2025, Mr. Stoeckle has served as Nikko AM's Executive Corporate Officer, Chief Investment Officer and Global Head of Investment, overseeing all of the firm's investment capabilities. Before taking the executive role, he was an outside director on Nikko AM's board since April 2024. The firm has benefitted from Mr. Stoeckle's extensive experience in firmwide executive and investment leadership as well as his familiarity and connections with the investment management industry in the US. Prior to joining Nikko AM's board, Mr. Stoeckle was with Adams Funds in the US, where he served for 10 years as President and board member, before taking a non-executive director role in 2023. He was previously CIO of US Equities and Global Sector Funds at BNP Paribas Investment Partners (currently BNP Paribas Asset Management), and CIO of US Equities at Fortis Investments. After taking over as President and Country Head of Nikko Asset Management Americas Inc., Mr. Stoeckle will continue in his global roles.

Current Nikko Asset Management Americas Inc.'s Chief Executive Officer and Country Head James Wesley will remain with the firm until the end of October 2025 to ensure a smooth transition, before departing to pursue other interests.
